Document prepared by the Office of the Union

1. At its forty-second session, held on October 17, 1990, the Consultative Committee decided to recommend to the Council that the following States and organizations should be invited as observers to the Diplomatic Conference of 1991 for the Revision of the UPOV Convention:

i) all those States that are members of the United Nations, of a specialized agency in relation with the United Nations system or the International Atomic Energy Agency, or are parties to the Statutes of the International Court of Justice. A list of such States, drawn up on the basis of the situation as of the date of this document, is given at Annex I to this document;

(ii) the intergovernmental and international non-governmental organizations listed in Annex II. That list is subdivided as follows: organizations within the United Nations family; economic cooperation and integration organizations; patent cooperation organizations; organizations of a scientific nature in the sector of plant varieties, seed, genetic resources and conservation of nature; organizations representing lobby groups.

2. The attached lists will be annexed to the provisional rules of procedure of the Diplomatic Conference.
