## Plant Variety Protection: Latest Statistics

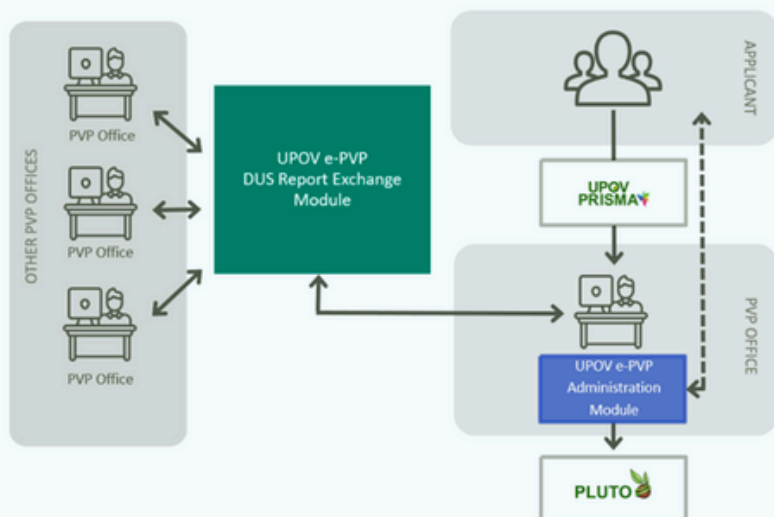
The latest data from UPOV members reveals important trends in plant variety protection (PVP) over the past year:

- **28,998** applications have been filed for PVP across UPOV members in 2023—showing continued global commitment to innovation in plant varieties.
- **21,088** titles granted reflecting the extensive protection awarded to breeders worldwide.
- **8,544** titles have ceased.
- **195,356** titles are in force, a record-breaking number safeguarding plant varieties across UPOV members.

## Introducing the UPOV e-PVP system to Streamline Plant Variety Protection

UPOV e-PVP offers a comprehensive set of digital tools to support UPOV members in effectively implementing the UPOV system of plant variety protection (PVP). These tools include:

- **UPOV PRISMA:** Our online application tool for transmitting PVP application data directly to PVP offices. ([link here](#))
- **UPOV Plant Variety Database (PLUTO Database):** A valuable resource offering detailed information on plant varieties and a similarity search tool for variety denominations ([link here](#))
- **UPOV e-PVP Administration Module:** A fully digital system that allows PVP offices to manage applications, communicate with applicants, publish key information, and seamlessly transmit data to the UPOV Plant Variety Database. ([link here](#))
- **UPOV e-PVP DUS Report Exchange Module:** A platform facilitating the exchange of DUS (Distinctness, Uniformity, and Stability) reports between PVP offices. ([link here](#))

Together, these tools form the foundation for collaboration among UPOV members in the administration and examination of PVP applications, driving efficiency and enhancing cooperation.

## The use of UPOV e-PVP is expanding!

Currently, 12 UPOV members are committed to using the UPOV e-PVP DUS Exchange, as of November 2024.

Additionally, 3 UPOV members—Ghana, the United Kingdom, and Viet Nam—are using or set to use UPOV e-PVP Admin.

Since its recent launch, the UPOV e-PVP Admin module has successfully transferred its first 4 applications through UPOV PRISMA from 3 plant breeders, covering 4 different crops.

The UPOV e-PVP DUS exchange module has enabled exchanging 7 DUS reports between the Kingdom of the Netherlands and Viet Nam.
