UPOV Council Holds Extraordinary Session

The Council of the International Union for the Protection of New Varieties of Plants (UPOV) held its twenty-ninth extraordinary session on March 30, 2012.

Round-up of key developments:

Ratification of the 1991 Act

The Council was informed that Ireland, which had been a member of the Union since November 8, 1981, had deposited its instrument of ratification of the 1991 Act of the UPOV Convention on December 8, 2011, and had become bound by the 1991 Act on January 8, 2012. Observers

Observer status was granted to the African Seed Trade Association (AFSTA) for the Council, the Administrative and Legal Committee (CAJ), the Technical Committee (TC) and the Technical Working Parties (TWPs). of in UPOV А list observers Bodies can be consulted at http://www.upov.int/members/en/observers.html

Extension of the appointment of the Vice Secretary-General

The Council extended the appointment of the Vice Secretary General from December 1, 2012, until November 30, 2015, and expressed its appreciation for his excellent performance.

Symposium on the benefits of plant variety protection for farmers and growers on November 2, 2012

The Council endorsed the plans for the "Symposium on the benefits of plant variety protection for farmers and growers" (Symposium), to be held in Geneva on November 2, 2012.

The aim of the Symposium is to provide illustrations of how plant variety protection can improve incomes for farmers and growers by supporting the development and supply of new, improved varieties that are suited to their needs. The Symposium will also provide examples of how farmers and growers can use plant variety protection as breeders.

The Symposium will be webcast.

Test Guidelines

The Council welcomed the adoption by the Technical Committee of eight new UPOV Guidelines for the Conduct of Tests for Distinctness, Uniformity and Stability (Test Guidelines) and eight revised Test Guidelines. The new Test Guidelines were for Blue Honeysuckle, Buckwheat, Canna, Echinacea, Hemp, Heuchera & Heucherella, Oncidium and Shiitake. The Test Guidelines revisions were for Durum Wheat, French Bean, Kalanchoe, Kiwifruit, New Guinea Impatiens, Parsnip, Radish and Strawberry.

Experience of members of the Union in the Examination of New Plant Varieties

The Council noted that the number of genera and species for which members of the Union had practical experience in the examination of distinctness, uniformity and stability (DUS) had increased from 2,679 in 2011 to 2,726 in 2012 (+1.75%). The Council also noted that information on members of the Union with practical experience in DUS examination was freely accessible via the GENIE database.

Officials of observer States / intergovernmental organizations endorsed by the relevant representative to the UPOV Council (One non-fee paying student per State / intergovernmental organization; Additional students: CHF1,000 per student)

Category 3: Others Fee: CHF1,000

Please note that registration of participants in categories 1 and 2 must be accompanied by an endorsement from the representative to the UPOV Council of the UPOV member or observer, as appropriate, formally nominating the participant.
