SUPPLEMENT TO DOCUMENT C/XIII/4

prepared by the Office of the Union

1. In view of the advice given by the Consultative Committee, the following changes are proposed in the draft Program and Budget contained in document C/XIII/4:

- ad UV.02 reduction from 9,000 Swiss francs to 7,000 Swiss francs
- ad UV.05 reduction from 32,000 Swiss francs to 30,000 Swiss francs
- ad UV.09 deletion of the amount of 28,000 Swiss francs since this amount will be covered from the Reserve Fund.

The increase of 4,000 francs is mainly due to provision for furniture and a typewriter for use by the incumbent of the proposed new "G" post.
