# DEVELOPMENT OF INFORMATION MATERIALS CONCERNING THE UPOV CONVENTION

Document prepared by the Office of the Union

#### Introduction

- 1. The Administrative and Legal Committee (CAJ), at its fifty-second session, held in Geneva on October 24, 2005, agreed an approach for the preparation of information materials concerning the UPOV Convention, as explained in paragraphs 8 to 10 of document CAJ/52/4. It also agreed to the establishment of an advisory group to the CAJ ("CAJ-AG") to assist in the preparation of documents concerning such materials, as proposed in paragraphs 11 to 14 of document CAJ/52/4 (see paragraph 67 of document CAJ/52/5, Report).
- 2. The agreed approach is summarized as follows: the Office of the Union will develop certain draft materials which it considers covers aspects of a straightforward nature and will circulate these to the CAJ for comments within a specified time. In other cases, where it is considered that there are difficult issues, where discussions at a CAJ session would be important for the development of suitable information materials, and also in cases where the drafts on seemingly straightforward materials provoke unexpected concerns when circulated for comments, it was agreed that the assistance of the CAJ-AG would be sought prior to the CAJ being invited to discuss those matters at its sessions.
- 3. An overview of the development of the information materials is provided in the Annex to this document.

- I. MATTERS TO BE CONSIDERED BY THE ADMINISTRATIVE AND LEGAL COMMITTEE AT ITS SIXTY-FOURTH SESSION
- 5. The CAJ, at its sixty-third session, held in Geneva on April 7, 2011, noted the proposal made by the Delegation of the Republic of Korea for the development of information materials on alternative dispute settlement mechanisms for breeders' rights, such as arbitration and mediation and the intervention by the representative of the International Seed Federation (ISF) on the existing ISF arbitration and mediation rules (see document CAJ/63/9 "Report on the Conclusions", paragraph 35).
- 6. The CAJ is invited to note that this matter is considered in document CAJ/63/3 "Alternative dispute settlement mechanisms".

#### II. PROGRAM FOR THE DEVELOPMENT OF INFORMATION MATERIALS

<u>Proposal to update the "UPOV Model Plant Breeders' Rights Gazette"</u> (document UPOV/INF/5)

- 7. The "UPOV Model Plant Breeders' Rights Gazette" (document UPOV/INF/5) was adopted by the Council on October 18, 1979 (see document C/XIII/17, paragraphs 12 and 12a). A copy of document UPOV/INF/5 has been posted on the CAJ/64 section of the UPOV website for information.
- 8. It is proposed to update document UPOV/INF/5 in order to:
- (a) reflect the wording of the 1991 Act of the UPOV Convention and of documents recently adopted by the Council (e.g. UPOV Model Form for the Application of Plant Breeders' Rights (document TGP/5 Section 2/3));

- (b) address relevant developments in the formats of national/regional Gazettes of members of the Union; and
  - (c) simplify the structure of the document.
- 9. Based on the above approach, it is proposed to present to the CAJ, at its sixty-fifth session, to be held in Geneva in March 2012, a program for the updating of document UPOV/INF/5.
  - 10. The CAJ is invited to consider the proposal to update the "UPOV Model Plant Breeders' Rights Gazette" (document UPOV/INF/5), as set out in paragraphs 8 and 9, above.
