REVISION OF THE CONVENTION:

ORDER OF THE PROVISIONS

Document prepared by the Office of the Union

- 1. The Council of UPOV, at its twenty-first ordinary session, charged the Administrative and Legal Committee (hereinafter referred to as "the Committee") with the preparation of the revision of the UPOV Convention. Draft revision proposals were considered by the Committee at its twenty-second session, in April 1988, and three revised drafts were considered at the three ensuing sessions of the Committee, the last of which drafts was also submitted for comments to the Fourth Meeting with International Organizations in document IOM/IV/2. All four drafts followed the order of the provisions of the Revised Text of October 23, 1978, of the UPOV Convention.
- 2. At its twenty-third ordinary session, held on October 16 and 17, 1989, the Council of UPOV endorsed a decision of the Consultative Committee taken at its fortieth session, on October 16, 1989 (see paragraph 23 of document CC/XL/5), that "the Office of the Union should submit to the First Preparatory Meeting for the Revision of the Convention (April 23 to 27, 1990) a new proposed text based on the structure which had been proposed by the Delegation of the Netherlands at the 1978 Diplomatic Conference but had not been retained in view of its belatedness."
- 3. The text of the revision proposals in document PM/1/2, submitted to the twenty-sixth session of the Committee (the First Preparatory Meeting), followed the proposal of the Netherlands. At that session, the Committee received a proposal from the Delegation of the Federal Republic of Germany for a revised order of the Articles, such proposal being set out in Annex III to the summary report of that session (document CAJ/26/1).

4. The Delegation of the Federal Republic of Germany has since that session, by letter dated May 15, 1990, submitted a proposal which, with minor amendments, follows the proposal submitted to the twenty-sixth session of the Committee. That proposal is set out in Annex I. Annex II contains the same proposal, with the addition of references to corresponding provisions in the draft text of the Convention contained in documents CAJ/27/2 and CAJ/27/4.
