TRANSMITTAL OF EXAMINATION RESULTS

Document prepared by the Office of the Union

1. In a letter dated June 6, 1978, addressed to the Office of the Union, the President of the Federal Varieties Office of the Federal Republic of Germany proposed to establish a UPOV model form for the transmittal of examination results also for cases where the examination results were not available at the time of the request, and had to be transmitted at a later date.

2. The letter of the Federal Varieties Office, and the standard letter used in the Federal Republic of Germany for the cases referred to above, are reproduced in Annex I to this document.

3. On the basis of the above-mentioned standard letter and the UPOV model forms already adopted for the Report on Technical Examination and for the Request of Examination Results, the Office of the Union has prepared a draft of a UPOV Model Form for the Transmittal of Examination Results, which is reproduced in Annex II to this document.
