2. These organizations have been consulted in the preliminary inquiry on the revision of the Convention, organized as a follow-up to the decisions taken in December 1986 by the Council at its twentieth ordinary session and the Consultative Committee at its thirty-fourth session, and in preparation for the nineteenth session of the Administrative and Legal Committee. Replies have also been given by the following international and national bodies, however:

- British Society of Plant Breeders Ltd
- CIPA Chartered Institute of Patent Agents of the United Kingdom
- GIFAP International Group of National Associations of Manufacturers of Agrochemical Products
- SEPROMA French Professional Union of Maize Breeding and Production

Those replies--and more generally the importance of the agenda item "revision of the Convention"--raise the question whether bodies other than those listed in paragraph 1 above should also be invited.

3. In order to give the Committee some guidance, the Office of the Union wishes to call attention to the following:

(i) In addition to the organizations mentioned in paragraph 1 above, the following international non-governmental organization has been invited to the 1978 Diplomatic Conference (but has not attended):

IFAP International Federation of Agricultural Producers

(ii) In addition to AIPH, ASSINSEL, CIOPORA, COMASSO and FIS, the following organizations were invited by UPOV to the information meeting organized jointly by UPOV and WIPO on January 10, 1986:

ABA American Bar Association

AIPLA American Intellectual Property Law Association

(iii) WIPO invites the bodies listed in the Annex hereto to the sessions of its Committee of Experts on Biotechnological Inventions and Industrial Property. So far those bodies have delegated altogether some 20 to 30 persons to the sessions.
