OBSERVATIONS OF THE MINISTRY OF AGRICULTURE

Letter, dated August 24, 1978, from Mr. Md. Touhid Khan,
Deputy Secretary, to the Secretary-General of UPOV

Sub:- Comments on UPOV's document DC/4 on International Convention for the Protection of New Varieties of Plants

I am directed to state that Government of Bangladesh have been pleased to comment on the above mentioned document as under:-

- I. In paragraph (4) (a) of Article 13 (Variety Denomination), Alternative I: "in any Member State of the Union applying the provisions of the Convention to the genus or species to which the variety belongs" is preferred.
- II. In paragraph (8) (b) of the same Article, Alternative I is preferred.
- III. In paragraph (9) also of the same Article, omission of the words in square brackets is not preferred.
